27 This matter came before the court on January 18, 2008 on Defendants Matthew Katzer
28 and Kamind Associates, Inc.'s Motion for Sanctions under Civil L.R. 7-9(c) and Fed. R. Civ. P.
29 11 against Victoria K. Hall. The court reviewed the parties' written submissions and oral
30 argument and finds as follows:

- 1 1.) Attorney Victoria K. Hall has violated Civ. L.R. 7-9(a), (c) and Fed. R. Civ. P. 11 by
- 2 filing a second motion for reconsideration of the dismissed cybersquatting claim of
- 3 action.
- 4 2.) Defendants should be awarded their reasonable attorney fees and costs incurred in
- 5 presenting this motion pursuant to Fed. R. Civ. P. 11(c)(1)(A) against Victoria K. Hall
- 6 and in responding to the Plaintiff's second motion for reconsideration.
- 7 3.) Victoria K. Hall should be required to pay either a monetary penalty to this Court or an
- 8 equivalent non-monetary sanction to deter repetition of the present conduct or any
- 9 similar conduct. Fed. R. Civ. P. 11(c)(2).

10 Therefore, based upon the above findings and being fully advised in the premises, it is

11 ORDERED that Victoria K. Hall pay Defendants reasonable attorney fees and costs in the

12 amount of \$ _____ and it is further ORDERED that Victoria K. Hall

13 _____ in order to deter repetition of the sanctioned conduct.
