
**DECLARATION OF MATTHEW

- 2 1. I am the controlling shareholder and operator of the close corporation Kamind

12 document contains confidential commercial information. This designation was
13 not made for any improper purpose such as to impose any unnecessary expense
14 or burden on Plaintiff.

- 16 4. My deposition testimony transcript at page 33 through page 34 attached as
17 Exhibit F to the Declaration of Victoria Hall in Support of the Administrative
18 Motion to Seal [Dkt.#342], has been designated Confidential because this
19 discussion relates to a document containing confidential commercial
20 information that was previously marked “Highly Confidential-Attorney Eyes’
21 Only” but has since been re-designated as Confidential (Exhibit C to
22 [Dkt.#342]. Pages 42-Page 44 Line 17 relates to my discussion of documents
23 marked confidential by QSI, but not by me. Page 44, line 18 through page 50
24 discusses non-confidential information and should not be sealed.
